# 1. Welcome

# 3. Discussion on the social media crisis

Claudia Kretschmer presented information from a crisis counselor on helping our organization deal with the issues on social media and facing our sport. Tips were given to help anchor the organization in it's goals and mission.

# 4. Renaming the association

The BOD discussed renaming the association to United States Gymnastics Club Owners Association (USGCOA). It was agreed to discuss costs and time frame with the attorney and move forward.

# 5. The mission of the USGCOA was established:

The mission is to provide an outlet for gymnastics club owners to have their collective voices heard.

- Communication
- · Deliver value to each member striving to exceed the member's expectations
- Uphold a sense of community and to acknowledge past contributions
- Fiscal responsibility
- Meet the needs of a diverse membership
- Serve the greater good of the sport of gymnastics
- · Manage the Association through team work and open, honest communication

# The Bylaws Committee (Sandy Flores, Brent Phelps, Kim Thomson) presented the initial draft of the bylaws.

The BOD reviewed the bylaws and they were updated to reflect the following:

- Association name will be United States Gymnastics Club Owners Association. (USGCOA)
- Registered agent is Brent Phelps.
- · Charter members are founding members of the organization. These members have donated \$1000 to help get the organization started.
- All members must own a club.
- · BOD meetings will be held annually.
- Reimbursement to board members up to \$500 for travel to meetings.
- · Annual open meeting to be held at the Club Owners Summit. This would include club owners and vendors.
- Members must be in good standing.
- · Members not in good standing will be removed from the Association and will stop receiving benefits.
- Inactive members may reactivate.
- · Charter membership dues are \$1000 and will be accepted until December 31, 2018. Initial membership will go through December 31, 2019.
- · Membership dues are to be paid annually.
- Each member club will receive one vote. One vote per club, not per location.

# 7. Discussion on benefits of membership

- Charter membership is good through 2019.
- Providing legal counsel of up to 1-hour free consultation with the USGCOA attorney of up to \$350 per member club.
- Industry discounts with vendors and suppliers
- Access to educational library
- FAQ page
- Survival kit
- Advertise member club invitational meets on USGCOA website.
- Access to clubs emails.
- Safe sport for dummies guide.
- Stream-line communication.

# 8. It was discussed that the USGCOA will hold a Summit for all membership.

This will be held in October 2019 in Las Vegas.

The BOD will research venues for this event.

# 9. Discussion of Industry Sponsorship. Scott Roberts will be heading the vendor list with submission from other board members. Sandy Flores will create a vendor application form.

- Cost per vendor sponsorship \$1000
- Vendor will be listed on the USGCOA website.
- May become a "preferred" vendor by providing larger discounts.

#### 13. Social Media

Lindsey Stancil will maintain Instagram account and Sandy Flores will maintain the Facebook page. There was further discussion regarding positive messaging and education on social media.
